

KIA Seltos Experience – WIN A TRIP TO K-POP AWARDS/ THE AUSTRALIAN OPEN TERMS & CONDITIONS

1. Terms and conditions applicable to the KIA Seltos“WIN A TRIP TO K-POP Awards/ The Australian Open.” Competition (“Competition”) conducted by KIA Motors South Africa (Pty) Ltd (“Promoter”).
2. The Competition will run from 11 October 2019 to the 28 October. Entries received after the closing date will not be considered.

WHO CAN ENTER

1. Participants must be 18 years or older, have a valid driver’s license, have a valid identity document, a passport valid for 6 months from 31 January 2020, participants must be a South African citizen or a permanent resident of the Republic of South Africa and reside in the Republic of South Africa during the period of the Competition up until the redemption of the prize (“Participants”/”you”/”your”).
2. Participants wishing to enter must register to experience the New KIA Seltos on www.kiaseltos.co.za to be considered eligible for the prize.
3. Only 1 (one) entry per person will only go into 1 (one) main lucky draw for each experience, while an entrant may register for both experiences, they will only be eligible to win one. In the event that one winner is selected for both experiences, they will be provided the option to select their preferred one and forfeit their second choice, afterwhich another contestant will be drawn.
4. Entries must be by the participant and not by a third party on the participant’s behalf.

HOW TO ENTER

1. Participants are to register their details to experience a KIA Seltos from 11 October 2019 to 28th October 2019.
2. The winner will be determined at the end of the Competition period and will be selected by a random draw overseen by an independent party in terms of the Consumer Protection Act 68 of 2008.
3. The winner will be announced on the 4th of November, after the close of the Competition. The winner will be contacted via telephone or e-mail on the phone number and/or e-mail address registered on www.kiaseltos.co.za.
4. KIA Motors South Africa will make 3 (three) attempts to contact and notify the selected winner. If the selected winner cannot be contacted personally after 3 (three) attempts, or if after first being contacted by the Promoter, is not reachable, or the winner fails to provide the Promoter with the required information to hand over the prize, the winner will forfeit the prize and a replacement winner will be selected from the names drawn from remaining qualifying participants. This process shall continue until the winner has been contacted and the prize has been awarded in terms of the Competition rules.

5. KIA Motors South Africa (Pty) Ltd will facilitate all travel arrangements.

PRIZE

1. Participants can enter and stand a chance to win 1 (one) return flight in economy class for 2 (two) people (one winner plus one partner) to their chosen experience,

- from Johannesburg, South Africa, including travel insurance, a pre-determined, 4-day and 3-night full hospitality program, hosted by KIA Motors Corporation, accommodation for two people (in one room), meals, transportation, as well as tickets to the K-Pop Awards in South Korea or The Australian Open in Melbourne.

2. By entering, a Participant acknowledges that personal information about the Participant will be shared with the Promoter and KIA Dealerships to the extent necessary to conduct the Competition and for the prize to be delivered to prize winner.
3. All personal information relating to the Participants will be used solely in accordance with South African consumer and data protection legislation.
4. By entering this competition and winning, the winner (and to whom they give the second ticket too) may be required to participate in marketing or promotional activities that include social media postings.

GENERAL

1. The Promoter of this competition is KIA Motors South Africa (Pty) Ltd, registration number 1968/003273/07.
2. Participants may not enter or receive a prize if they are directors, members, partners, employees, agents of or consultants of the Promoter and their subsidiaries, holding companies, divisions and/or associated companies or of the advertising or promotion agencies or any other person who directly or indirectly controls or is controlled by KIA Motors South Africa, or their spouses, life partners, immediate family members or business partners.
3. By entering this Competition, all Participants agree to be bound by these terms and conditions, and the Promoter's decision regarding any issue with the Competition will be final and binding and no correspondence will be entered into.
4. Incomplete or incorrect entries will not be eligible to be entered into the draw.
